- j. Environmental Officer
  - 1. Meat free service: results from the poll, 200 responded with 70% in favour. Toby to speak to Joy about a trial period this week. There was a strong majority, there was a vocal but small minority - consider this is a pilot period and an opportunity to address other issues related to catering. Toby will also discuss this with Joy.
    - 1. Noting that the trial period has to be given the opportunity to succeed.

- 2. It is important that students who are interested do attend these meals to show that it is relevant.
- 2. Question on recycle bins in student rooms: Jansuz is fine with extra recycle bins in rooms but has to be funded by the CR, but this would not be included in the cleaning actions, it will be up to students to address this.
  - 1. To follow-up on recycle in public bathrooms.
  - 2. The CR shouldn't have to pay for College improving its recycling.
  - 3. Noting also that recycle bins are available for students to take out their own recycle.
  - 4. To be raised in the Estates Meeting this week.
- k. Punt Admiral
  - 1. The St Edmund's College punts are drying out nicely and refurbishments have started to sand down, varnish and repair their hulls, gunwhales, and duckboards. Alex is expecting photographs.
  - 2. Alex has enquired about naming the unnamed punt Grace Lake which seemingly there is no problem other than confirming with college.
  - 3. Alex has started organising the licences and moorings to be paid for through the river cam conservancy and st john's domestic bursar. The punt's should be back on the river late march/early April.
  - 4. New poles shouldn't be a problem and should be suited to amateur punters.
  - 5. Video to come to demonstrate the proper and effective technique for punting.
  - 6. Alex has yet to find a suitable hat fit for an admiral.
